REGISTRATION COMPLIANCE

This form of declaration, along with the Certificate of Registration and a current Letter of Good Standing from the Registrar, must be submitted to the SFF Secretariat no later than 30 days after the close of the season.

We confirm that all Players and Club & Team officials will be duly registered and activated in the SFF Player & Officials Registration platform (FIFA Connect). We hereby confirm our agreement to the Club's and Players' registration requirements.

We confirm that our club will have a minimum twenty (20) players, in total either:

- registered and active in FIFA Connect, or,
- submitted to SFF FIFA Connect dashboard pending approval,

by no later than 15 days after the new season starts. The total count of these players must not exceed thirty (30). We hereby acknowledge that a new season starts immediately and as soon as the previous season closes.

Only electronically registered players possessing a FIFA ID through the FIFA Connect system are eligible to participate in SFF-sanctioned competitions. By registering, players agree to abide by the statutes and regulations of FIFA, CAF, and the Seychelles Football Federation.
